You may sell your investment on any working day in Ireland. Any income the Fund receives will be reinvested to grow the value of your investment.

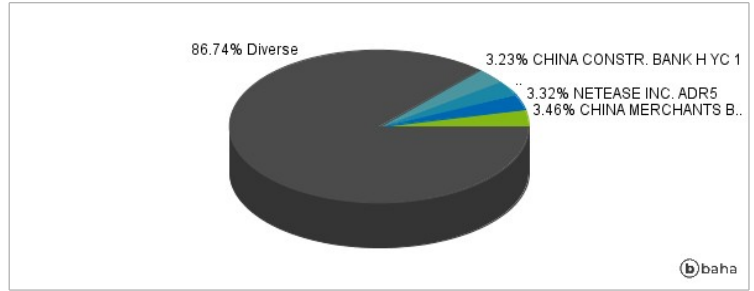
## Fondsspezifische Information

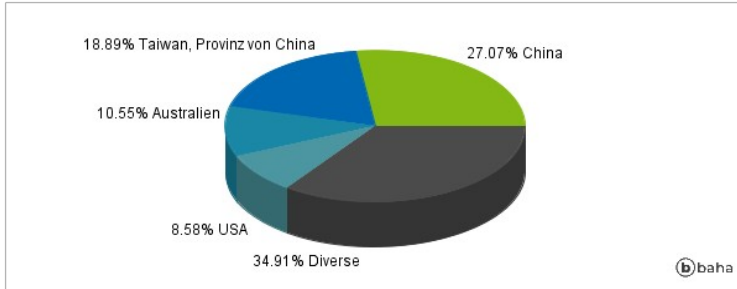

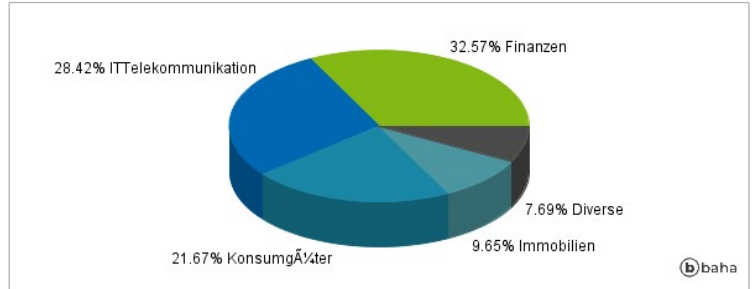
### Größte Positionen
