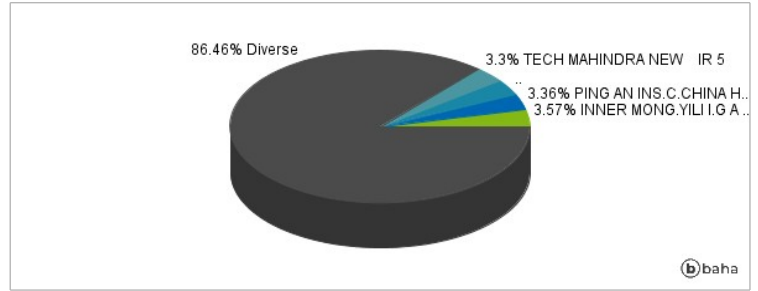

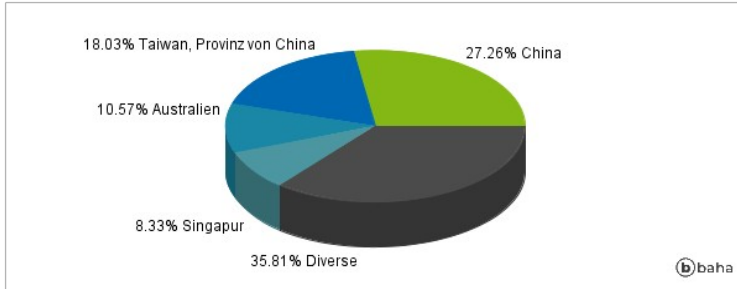

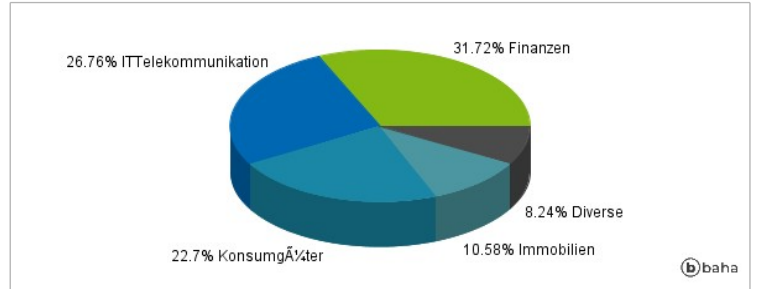
Größte Positionen
